 Knowyess that of Joshua Holcomb of Simsbury of the County  
 County of Hartford of the Colony of Connecticut in  
 Neweng Land for divers good causes and considerations me  
 Recurroto Moweing to the value of eleven pounds white  
 of 31 eleven pounds is to be paid in current silver mony  
 pay as is express on Bill bearing date with thefe  
 presents. His receipt whereof I acknowledge by thefe  
 presents therefore have sold given granted enfor  
 and confirmed and do by these presents fully wholly  
 clearly and absolutely sell allyn get out passe over  
 Ratifie and confirme unto Josiah Alford of Windsor  
 of the County and Colony abovagd one certayne piece  
 or parcell of Land being situate within the Town  
 shire of Simsbury on the eastward syde of the River  
 Ett. bounded eastwardly on the way that leads betwix  
 William Cads house Lott and 3<sup>d</sup> Joshua Holcombs  
 house Lott ouer the brook to Tarrys et bounded  
 Northerly on my own land. Westwardly on Tarrys land  
 Southwardly on a Vacancy left for a way ouer the brook  
 the 3<sup>d</sup> parcell of land is at south end fourre rods  
 on south eastwardly syde nept the way in length  
 tweenty fyve rods & foote on west syde thirtynine  
 foote rods & foote at North Easterly end is in breadth  
 thirtynine rods, being two acres reaching or extending from sd way  
 westward to Stephen Tarrys land or bounds which  
 so Land with the dwelling houfe standing thereon  
 fenes edifices and appurtinences therunto belonging  
 I the 3<sup>d</sup> Joshua Holcomb do for my selfe my heires  
 executors administrators and assignes make ouer and  
 convey alienat passe ouer to Josiah Alford abovagd  
 his heires executors administrators and assignes for ever. And  
 I do covenant and with the 3<sup>d</sup> Joshua Alford that before the time  
 of the enfealing and delivery of these presents. I haue  
 good right full power and lawfull authority to sell the houfe  
 and land and make ouer all the said premises to the aforesd  
 Josiah Alford and it shall be lawfull for the 3<sup>d</sup> Alford above  
 named and his heires executors administrators and assignes  
 for ever from time to time to take into his and their  
 custody the houfe and two acres of land as abovesd. haue  
 the profits privileges advantages conveniences rents  
 issues emoluments productions and emanations an  
 appurtinences therunto belonging without any lawfull  
 lett suit eviction ejection encumbrance or molestation  
 from me the said Joshua Holcomb or my heires executors  
 administrators or assignes for ever or any other person  
 or persons whatsoeuer claiming or that may claime  
 challenging or demanding the same or any part thereof  
 by me or by my means act intent privity title or  
 procurement arising any wife or derived from me  
 warranting hereby that it is free and clear and is  
 hereby fully and freely & leasly acquited discharged  
 and exonerated from all maner of former gift grant  
 bargains sales leases Mortgages Contracts bargaines debts  
 dowery or titles of doweries or encumberances of law  
 whatsoever arising or coming by vertue of any past  
 contracts hadon or suffered to be don either by my selfe  
 or my predecessours to the true performance of the  
 abovesd premises. I the abovesd Joshua Holcomb do  
 for my selfe my heires successors and assignes here unto  
 annex my hand and affix my seal this sixth of April  
 1697. and in the ninth year of the Reign of our Sovereign  
 KING William King of England : Joshua Holcomb

Bill Received by Joshua Holcomb & Josiah Alford

This Bill made ye 6<sup>th</sup> of April 1697 witnesseth that Josiah Alford of Windsor of the County of Hartford Colony of Connecticut Bereft me of my husband to pay or cause to be paid to Joshua Holcomb John Moore Commissioner of the sum of eleven pounds of Silver money at price currant as it passes from man to man at the several times of payment one pound to be paid now this spring and the rest to be paid at feare & payment viz 3<sup>rd</sup> 7<sup>th</sup> 4<sup>th</sup> the 10<sup>th</sup> of May 1699. His third and last payment to be paid the 10<sup>th</sup> of May 1700 all which abovesd payments are to be paid at the dwelling house of Joshua Holcomb in Simsbury paid to him said Holcomb his heires and executors or administrators this payment abovesd expressed are for all such two acres of land which I bought of the abovesd Joshua Holcomb as appears by an instrument of alienation & conveyance bearing date with these presents to his true performance of abovesd premises. The abovesd Josiah Alford bind my self my heires executors administrators & assignes firmly by these presents as witness my hand the day and year above written Josiah Alford
