PETITION TO PROBATE WILL.

Comes now your petitioner, Susie Dell McCulloch, and respectfully shows to the Court:

That she is a resident of Butler County, Kansas, and that her postoffice address is Towanda, Kansas.

That the decedent, Hervey C. Hayman, died on the 26th day of January, 1944, at his home in Butler County, Kansas, and that he was at the time of his death a resident of Butler County, Kansas.

That said decedent left a last will and testament, which is attached hereto, marked Exhibit "A" and made a part hereof.

That petitioner is the daughter of said decedent and one of the devisees named in said will.

That at the time of his death said testator was the legal owner of the following described real estate in Butler County, Kansas, to-wit:

The Northwest Quarter (NW. $\frac{1}{4}$) of Section Thirty-four (34), Township Twenty-five (25) South, in Range Four (4) East of the Sixth Principal Meridian,

of the approximate value of \$4,000.00; subject, however, to that certain warranty deed for the above described real estate executed by said testator as grantor to L. E. McCulloch and Susie D. McCulloch, grantees, dated April 18th, 1940 and recorded in Book 180 of Deeds at Page 568 in the office of the Register of Deeds of said county and state. That the interest in and to said real estate reserved to said testator in the aforesaid warranty deed was the only interest in real estate owned by the testator at the time of his death. That said testator had no interest in the real estate described in his will at the time of his death, and that due to mistake or typographical error the real estate hereinabove

described was described in said will as the Northeast Quarter of said Section Thirty-four (34) instead of the Northwest Quarter of said Section Thirty-four (34), and that said testator intended to devise by said will all his right, title and interest in and to said Northwest Quarter (NW.¼) of Section Thirty-four (34), Township Twenty-five (25) South, Range Four (4) East, in Butler County, Kansas. That the conditions in the aforesaid warranty deed had been fully complied with by the grantees named therein at the time of the death of said testator.

That at the time of the death of said testator he owned personal property, consisting principally of a savings account in a Building and Loan Association and an automobile, of the approximate value of \$525.00.

That decedent was a widower at the time of his death, and that he left surviving him as his sole and only heir at law your petitioner, Susie Dell McCulloch, whose residence and postoffice address is Towanda, Kansas.



That satisfactory proof by affidavit filed herein has been made that none of the heirs or devisees of said decedent is now in military service, as said term is used and defined in the Soldiers and Sailors Civil Relief Act of 1940, as amended, and it is ordered that the hearing on said petition now proceed to judgment.

The Court further finds that the document attached to said petition, marked Exhibit "A" and made a part thereof, is the last will and testament of the said Hervey C. 
