FAMILY SETTLEMENT.

That the real estate belonging to the estate of Mary Heath, deceased, be equally divided according to law among the undersigned, Stella M. Wilson, Artie Heath, Elmer Heath and Florence Klingler, share and share alike, and free and clear of any claims by way of advancement or otherwise.

JOURNAL ENTRY OF FINAL SETTLEMENT

Now on this 22nd day of May 1936 this matter came on for hearing upon the application of R. A. Haines, Administrator of ~~Execut~~, for final settlement and discharge. Said Administrator of ~~Execut~~ appeared in person and by M. A. Merten Attorney for said estate.

And the Court being fully advised in the premises finds that said Administrator of ~~Execut~~ gave notice of his appointment and of his intention to make final settlement at this time, by publication notices printed and published as provided by law, which said notices and the proof thereof are by said Court approved. And the Court further finds that the FINAL ACCOUNT was filed herein on the 18th day of April 1936 and that no objections or exceptions have been filed thereto, and the same is by the Court approved. The Court further finds that at the time of filing said account, said Administrator of ~~Execut~~ had collected from all sources, on behalf of said estate the sum of \$ 1770.30. That he had paid on claims and demands, approved and allowed by said Court, against said estate the sum of \$ 1770.30. That since filing said final account said Administrator of ~~Execut~~ has collected \$ 16.10 and has paid out, the sum of \$ 123.65 including Attorney's fees, Inheritance Taxes, and costs of Administration and that said Administrator of ~~Execut~~ claims and is allowed by said Court, the sum of \$ 50.00 for his services herein, leaving a balance in his hands of the sum of \$ 1247.66 for distribution.
