IMPORTANT CHANGES

PROPOSED IN THE RULES GOVERNING THE SCHOOLS.

No More Detention of Pupils at Recesses and After School Hours-Facts and Theories About Whipping - Standing Committees Abolished-The Rule Concerning Marriage of Teachers.

The committee on rules of the school council, Messrs. Backus, Buss and Boutall, held a four hours' session last night with Director Sargent and Supt. Day, and agreed upon a partial report to be submitted to the school council next Monday evening. Some radical changes have been agreed upon. All of the rules of the old board relating to standing committees, covering eleven pages in the manual, nave been entirely wiped out, and there will be no standing committees. It is proposed to transact all business either in committee of the whole or by means

of special committees. How this will work remains to be seen, and it is the opinion of gentlemen who have extended experience in school affairs, that it will be extremely inconvenient to transact business without standing committees. An interesting discussion was held last

evening in regard to corpor d punishment. The present rule reads as follows: No corporal punishment of any description shall be inflicted in any of the public schools, except in the boys' schools, where it should be resorted to only in cases of extreme necessity arising from flagrant and persistent disobedience. No other than a common rod or whin shall be angrant and persistent disobedience. No other than a common rod or whip shall be employed and all cases of such punishments shall be reported to the superintendent on blanks to be furnished by him for the purpose.

"I believe," said Mr. Backus, "that if we keep up with the advance of civilization and the spirit of the mineteenth center of the spirit o

tion and the spirit of the inneteeath century, we will amend that rule so that there will be no corporal punishment in the schools."

"Mr. Buss was opposed to entirely abellating corporal punishment. "I do not," said he, "believe in it, as a rule, but there are cases in which that kind of medicine is necessary."

"Corporal punishment has gradually decreased in the schools," said Supt. Day. "I can remember the time when we had only 10,000 pupils in the schools and we had 400 whippings in a single month. In the year previous to the one in which the board adopted a rule against corporal punishment there were only thirty whippings in the whole year. That reduction in the number of whippings was made by the teachers. There are times, however, when there is no remedy but whipping and I think the authority ought to be and I think the authority ought to be given to whip in such cases."

"The authority to whip," said Mr. Buss, "does away with the necessity for whip-

After some further discussion it was decided to allow the rule to stand after striking out the words "no other than a common rod or whip shall be em-

No pupil shall be detained at noon recess; and a pupil detained at any other recess shall be allowed to go out immediately thereafter. No pupil shall be detained for punishment in the afternoon ofter school leaves more than thirty minafter school hours more than thirty min-ntes at a time. Neither shall a whole class be detained for the misdemeanors

When the subject of evening schools was reached Director Sargent said he had not been able to consider it carefully, but he knew that it demanded careful study. He and Supt. Day seemed to be of the opinion that important changes in the management of the evening schools ought to be made and the matter was left for future consideration.

SEWER IN DOAN STREET.

A Twelve-Foot Affair Will Have to be Constructed to Care for the East End.

Messrs. Herrick, Meyer, Gardner, Engineer Force and Councilmen Bole and McKenney conferred with the village authorities of Glenville in the office of the thorities of Glenville in the office of the corporation counsel yesterday afternoon in relation to the construction of a main sewer in Doan street. The Glenville people represented that they had intended to build a twenty-inch sewer in the street, which would be adequate for their present needs, but the city decided that such a sower would be worse than uscless. The sewer would be worse than uscless. The city proposes to build a twelve-foot main sewer through Doan street for the accommodation of the sewage of the East End and the whole of Newburg. Such a sewer would cost \$24 per foot. The Glenville people would contribute a very small

share to the cost.

"The East End is building up so rapidly," said Gen. Meyer, "that the present system of sewerage will become inadequate in a very few years. A main sewer

The matter is as yet very much in embryo. It is not yet determined where the sewer will have its beginning. Another meeting will be held in about two woods.

This reduces the number of foundries still out to four—Lake Shore, Eclipse, Bowler & Co. and Maher & Brayton. Then it is believed that the Lake Shore and Eclipse companies will come to terms; but the strikers are not so sure as to the action of Bowler & Co. and Maher & Brayton. They rather expect them to make a fight, but are ready to meet them at every turn. The strikers say if these foundries employed but eight or ten men they might or fifty non-union men in the city possible and as long as the foundries in all the surrounding towns are paying higher wages than they are here it would be hard to induce them to come here at the present rates.

Burke of the Lake Shore company stated that he had no idea how long the strike would last nor any idea what would be the result of the meeting of their association Monday evening. UPHOLSTERERS STILL OUT.

The reported near settlement of the upholsterers' strike received a serious back-set yesterday and now the end is as remote as ever. The modified demands; asking for nine hours and no reduction in wages, were presented to the employers yesterday, but according to the reports made at the special meeting, held in Blahd & Heller's hall last evening, were re-fused. They claim that it is simply impossible to meet the demands under the prevailing prices. They are willing to take all the men back at the old terms,

but last night it was decided to continue the fight till their terms were recognized. The manufacturers are equally firm in their refusal and state that they will get along as best they can.


